## A. Major Interdepartmental Events/Announcements/Issues

## Positive or Negative

1. Direct Broadcasting by Satellite (DBS) (with DTI): can a viable scheme involving the BBC, Independent Television and UNISAT be worked out? [Decision likely to be necessary within weeks.]

#### Positive and/or Negative

1. Greenham Common "Peace Camp" (with MoD, DoT, Law Officers): possible move through civil action in the courts to remove the Greenham women [? end March. Local authorities to be engaged before then if action to go ahead.]

## Probably Negative

1. "Streamlining the Cities" (with DoE): emerging implications for Home Office of direct control over police and fire (cash and staff) and quest for savings in the Metropolitan areas [continuing].

2. "No-Passport Excursions" (with FCO): possible failure to reach agreement with the French about their continuation [continuing].

### B. Home Office Events/Announcements/Issues

#### Positive

1. Possible initiative to help black businessmen. [? Around Easter.]

2. Publication of Criminal Justice Working Paper: showing strategy on sentencing courts etc [? April].

3. Publication of Green Paper on Intermittent Custody: use of "weekend" imprisonment [? March].

4. Publication of Crime Figures for 1983: should show fall in recorded crime - though not in all categories some of which may be up [publication 15 March].

#### Positive or Negative

1. "Glue Sniffing": decision on whether to create an offence of supplying solvents if known that the glue to be used for sniffing. [Some public announcement before Easter likely.]

## Negative

1. Routine use of police cells for prisoners: problems in fulfilling objective of ending this. [February.]

2. Possible debate on amendment on 18R material at Report of Video Recordings Bill. [? end of March.]

3. Police Bill issues: particularly legal representation of police officers possibly leading to wider criticism of police complaints procedure. [February/March.]

4. CRE Report on Immigration Control: critical of work of immigration service and, by implication, Government policy [may leak in advance: publication not imminent.]

5. Devenport and the Forensic Service: implication of criticism of Mr Devonport's evidence in case of Bruce Lee's conviction for arson as far as other previous fire cases are concerned could be wide-ranging. Previous fire cases now being reviewed. [Already known by Jack Ashley MP. S of S before Select Committee on PCA on 14 February.]

6. Implications for immigration control of likely adverse decision by the ECHR at Strasbourg in the present "husbands cases" there. [Hearing likely to begin in Spring. But no decision likely until Autumn.]

7. Proposed deportation of the Pireira family [tuncing very uncertain; probably before Easter].
