

Dear Michael,

During the Prime Minister's recent tour of Scotland I discussed with her my concern about the state of our Local Government organisation within the Party.

Our next local elections are for our Regional Councils in 1986. The period from now to the start of the campaign will be crucial and we have begun the build-up of our preparations, the formation of policies and plans, and the selection of candidates. The most vital factor will be the co-ordination of the Conservative message to the people of Scotland and I am delighted that the Secretary of State for Scotland and his Ministers are being most helpful in this respect.

However, as I explained to the Prime Minister, I believe that it would be beneficial if we were to appoint another Vice Chairman with sole responsibility for Local Government organisation within the Party. The person I have in mind is Mrs. Jean Chalmers of East Kilbride. Both Dr. Alistair Smith, my Deputy Chairman and Ian Lang, my Vice Chairman approve of this suggestion.

If the Prime Minister is also in agreement it would be helpful if the appointment could be made fairly soon as the fight to gain seats in the Regional Council elections must begin immediately and this of course will lead on towards the next general election. If, however, the Prime Minister prefers that we should continue as at present, then we will allocate responsibility for areas of the country amongst the three of us and endeavour to achieve the same improvement.
