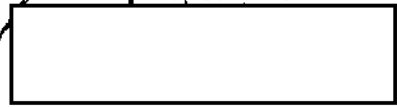
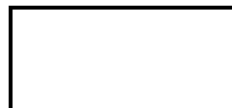

ON 7/21/92, A UNIQUELY PLACED SOURCE OF THE BOSTON OFFICE, WHO HAS AN ESTABLISHED HISTORY OF INVOLVEMENT WITH THE PROVISIONAL IRISH REPUBLICAN ARMY (PIRA), ADVISED THAT THEY WERE AWARE OF A PLOT TO ASSASSINATE FORMER BRITISH PRIME MINISTER, LADY MARGARET THATCHER, IN THE UNITED STATES BY TWO PIRA MEMBERS WHO ARE PRESENTLY IN THE UNITED STATES. SOURCE HAS MET BOTH INDIVIDUALS IN AT LEAST ONE FACE-TO-FACE MEETING.

SOURCE INDICATED THAT [REDACTED] HAD COME TO BOSTON IN MID-JUNE, 1992 HAVING BEEN SENT BY [REDACTED] IN A MEETING WITH SOURCE ALONE, [REDACTED] UPON VIEWING A STILL PHOTOGRAPH OF THATCHER ON T.V. TOLD SOURCE "WE'RE GOING TO TAKE CARE OF HER. SHE'S COMING HERE SOON". IN ANALYZING THIS, SOURCE, AN INDIVIDUAL HIGHLY FAMILIAR WITH PIRA TACTICS AND OPERATIONS TOLD DEBRIEFING FBI AGENTS, "IF THEY SAY THEY'RE GOING TO SHOOT YOU, I'D BE LOOKING FOR MY VEST".

SOURCE FROM THE SAME PHOTO SPREAD SELECTED A PHOTOGRAPH OF [REDACTED] STATING THAT [REDACTED] LOOKED "JUST LIKE THE [REDACTED] SOURCE ELABORATED STATING THAT SHORTLY AFTER [REDACTED] WAS ARRESTED AND RELEASED BY THE BOSTON POLICE DEPARTMENT, [REDACTED] CAME TO BOSTON TO CHASTISE [REDACTED] FOR BEING CARELESS. SOURCE STATED THAT IT WAS OBVIOUS THROUGH OBSERVATION AND DISCUSSION WITH [REDACTED] THAT HE WAS IN CHARGE OF [REDACTED].
